Discussion ensued regarding the items to be discussed including:

Mayor Hunter, with the mutual consent of Council, considered it appropriate to vary the order of the agenda to discuss added item 12(b) Hospital at this time.

Discussion continued regarding the importance for all Members of Council to contact our M.L.A. to show support for our hospital and encourage our M.L.A. to fight hard to ensure that our hospital maintains its status and does not get downgraded to a lesser care facility status.

Town Manager, Rob Stoutenberg advised that traditionally the July and August Committee of the Whole Meetings have been cancelled due to a lower work load over the summer. A special meeting may be called, if necessary to deal with any emerging issue(s).

#### (d) Memo re: RInC Program

Town Manager, Rob Stoutenberg advised that on Friday May 29<sup>th</sup>, 2009, Administration on behalf of Council submitted an electronic application for funding under the recently announced Recreation Infrastructure Canada (RInC) Program. The application is for \$2,439,600 and consists of renovations and upgrades to the arena component at the Stettler Recreation Centre.

The deadline date for the first intake of applications was May 29<sup>th</sup>, 2009. There is a second intake deadline of June 29<sup>th</sup>, 2009 however with only \$54 million in federal money being available in western Canada Administration felt it would be wise to get the application included in the first intake.

The program is specifically directed at recreation facility renovations with the Federal Government committing 1/3 shared funding up to a \$1 million dollar maximum. There is no corresponding provincial commitment; no new provincial dollars only existing grant programs (MSI, CFEP, CIP etc).

Project selection criteria (is supposed to) include:

- construction readiness;
- planned completion date;
- incrementality; and,
- the extent to which other funding is leveraged.

Council's support was demonstrated in the application via a letter signed by Mayor Hunter, however no formal Council resolution is required as Administration is just "Chasing the money" at this time.

A major upgrade to the arena has been included in the past two Capital Budgets, always as a future year project and subject to significant governmental funding; thus this project meets their criteria for incrementality, with planning and construction capable of being completed by March 31st, 2011.

The long list of proposed upgrades addresses many of the concerns previously identified via focus group input.

Discussion ensued regarding the accuracy of some of the cost estimates and/or educated guesses, and Council's mutual support for incrementally advancing this significant project should 1/3<sup>rd</sup> Federal funding be approved.

Moved by Councillor Richards that the Town of Stettler Council supports and approves the submission of an application for funding under the Federal RInC Program for the purpose of undertaking renovations at the Stettler Recreation Centre that would not otherwise be able to occur at this time, as proposed, without financial support from the RInC Program.

## (e) Memo re: Roof Top Unit Tender

Mayor Hunter declared a possible conflict of interest and by departing the meeting excused himself from discussion and voting on the matter.

Deputy Mayor Councillor Campbell assumed the chair.

Town Manager, Rob Stoutenberg explained that the 2009 Capital Budget includes \$15,000 for a new roof top cooling unit for the fitness centre. Three tenders were submitted as follows:

- Action Plumbing & Excavating
- Burmac Mechanical 2000
- Keith's Refrigeration
\$14,875.00
\$16,970.00
\$22,000.00

A second roof top cooling unit over the conference room has also been decommissioned due to a leaking heat exchanger. This unit will be of similar size and cost. Savings in crane costs would be realized if both units were installed the same day and by the same company.

Because of bookings accepted for this area, the roof top unit must be replaced as soon as possible. Combined costs and funding sources are as follows:

Discussion ensued regarding the size of the cooling unit required above the conference room (being slightly larger at 18 tons), and the rationale/fairness of negotiating directly with the initial low bidder for a second unit.

Town Manager R. Stoutenberg stated that Administration does not have any concerns with quality or the expected performance of any of the three manufacturers/brands that have been locally quoted.

Discussion continued regarding the timelines and/or the potential delays associated with going to tender for the second unit, as well as crane costs savings.
