<u>Purpose:</u> To set the lease fees for aviation use and aviation-commercial use at

the Stettler Town & County Airport for the purpose of erecting hangars, workshops, offices or other buildings required for aviation

use.

Policy Statement: That the Town of Stettler and lessee will have entered into an "Airport

Hangar Site Lease Agreement".

The lessee is required in this Agreement to pay to the Town of Stettler a hangar site lease fee for aviation and aviation-commercial use of

the leased land.

Therefore, effective January 1, 2006 the hangar site lease fees as per the Agreement for leased land adjacent to the asphalt tarmac and

the gravel/oiled road shall be:

1. \$.10 per sq. ft. for aviation use.

2. \$.20 per sq. ft. for aviation-commercial use.
